COOL EFFECT PERFORMS A DEEP ANALYSIS ON BOTH THE SCIENCE AND THE BUSINESS STRUCTURE OF PROJECTS THAT CLAIM TO REMOVE CARBON FROM THE ATMOSPHERE. ALL PROJECTS UNDER CONSIDERATION MUST FIRST BE APPROVED BY THIRD-PARTY STANDARD-KEEPING ORGANIZATIONS SUCH AS THE GOLD STANDARD, VERIFIED CARBON STANDARD, AND CLIMATE ACTION RESERVE, AMONG OTHERS.
